## Consignment Agreement

1. The Consignor hereby warrants, represents and attests that he/she is at least 18 years of age, is the owner of all goods consigned to Wedding Warehouse, LLC and he/she has the legal right to enter into this Consignment Agreement; and that the goods are saleable and/or free & clear of liens, loans, legal proceedings or other ownership encumbrances.
2. The consignment period will be 90 days. In some cases, extensions will be granted.
3. A consignment extension may be granted at the sole discretion of Wedding Warehouse, LLC. If an extension is granted, the item may be subject to markdown which will be agreed upon between Wedding Warehouse and the consignor. A revised contract will be issued and must be signed by the consignor and returned to Wedding Warehouse before the item can be sold.
4. The price is agreed upon during the original consignment appointment. That price will not be changed during the 90 days consignment period. The only time the price of an item can change would be after an extension is granted, and only if agreed upon by both consignor and consignee.
5. The owner (consignor) will receive 50% of the selling price.
6. Gowns and dresses must be cleaned in advance. Wedding Warehouse, LLC will not accept any items with stains, splits, or broken fixtures including zippers, buttons and loop holes.
7. Consignor agrees that any item consigned to Wedding Warehouse, LLC may be displayed whenever and wherever Wedding Warehouse, LLC chooses. This includes internet advertising and marketing.
8. Consignor acknowledges that Wedding Warehouse, LLC will have a monetary investment in time, space and advertising in selling consignor's items. Consignor agrees not to remove consigned items prior to the end of the 90-day consignment period. If a consigned item is removed prior to the end of the consignment period, the

consignee agrees to pay Wedding Warehouse, LLC a fee of 15% of the asking sale price of the consigned item plus any additional costs incurred by the consignment.

9. Consignors will be paid by check. Checks are automatically issued within 15 business days for the prior months sales.

10. Consignor acknowledges that Wedding Warehouse, LLC maintains fire and liability insurance coverage only. All reasonable care will be taken to ensure the safety of items consigned with Wedding Warehouse, LLC, however, items are left at the consignor's risk. Consignor acknowledges that Wedding Warehouse, LLC is open to the public and is not responsible for any loss due to damage, theft or natural disaster.

11. It is the responsibility of the consignor to notify Wedding Warehouse, LLC of any change of contact telephone number or address.

12. It is the responsibility of the consignor to know when the consignment period expires. Upon expiration of the consignment period, and if the consignment period has not been extended, the consignor has seven (7) days to pick up any unsold items. You must notify us at least one business day in advance that you are coming to retrieve your unsold item(s). We need this time to pull your item(s) and have them ready for you to pick up. Unless prior arrangements have been made and agreed upon in writing by both the consignor and Wedding Warehouse, LLC any item left for more than seven (7) days after the end date (SEE LAST PICKUP DATE ABOVE) of the consignment period will be considered abandoned and become the sole property of Wedding Warehouse, LLC and may be disposed of or donated to any charity of choice.

This Consignment Agreement, along with the attached inventory sheet, constitutes the entire Agreement between the parties. By signing this: (1) I agree to the above terms and conditions of this Consignment Agreement, (2) that the attached inventory sheet is an accurate number and listing of the items I wish to consign and (3) that I have received a copy of this Agreement:
